REGULAR MEETING OF COUNCIL – July 18, 2023

A Regular Meeting of Council was held on July 18, 2023 at the County of Vermilion River Administration Office in Kitscoty. Council approved the following resolutions:

Sale of Dewberry Property

Council approved the application of Holly Holman and Alan Bowman for the purchase of the lands in the Hamlet of Dewberry located at 145-1st Ave South, Lot 1 Block 9 Plan 2238HW for the purchase price of \$8,000.00 + GST. And all applicable transfer cost, all revenue shall be applied to outstanding taxes and the purchaser shall develop the lands within two (2) years from the date of title transfer.

Council approved to receive \$8,000.00 as a tax receipt against Lot 1 Block 9 Plan 2238HW and write off any remaining tax balance until title transfer date.
