COUNTY OF VERMILION RIVER BYLAW NO. 18-16

A BYLAW OF THE COUNTY OF VERMILION RIVER, IN THE PROVINCE OF ALBERTA, TO AMEND BYLAW 14–04, THE TRAFFIC BYLAW

WHEREAS pursuant to section 191 of the *Municipal Government Act*, RSA 2000, c M-26, as amended, the council of the County of Vermilion River is authorized to amend a bylaw;

NOW THEREFORE the Council of the County of Vermilion River, duly assembled, enacts as follows:

- 1 Bylaw No. 14-04, the Traffic Bylaw, is amended by this Bylaw.
- 2 Subsection 2(2) is amended by adding the following after Subsection 2(2)(i):
 - (i.1) "Non-Standard Configuration Vehicle" means a Vehicle that:
 - i. has a tridem axle group for which a permit is required pursuant to the *Traffic Safety Act* and regulations thereunder; or
 - ii. that has one or more removable axles or axle groups installed either:
 - a. between a Vehicle and an attached trailer; or
 - b. behind a trailer that is attached to a Vehicle,

so as to distribute the load being towed by the Vehicle.

3 The following is added after Section 9:

Non-Standard Configuration Vehicles

- 9.1(1) No Person shall operate a Non-Standard Configuration Vehicle on a highway unless a permit has been issued by the Chief Administrative Officer.
- (2) No Person shall operate a Non-Standard Configuration Vehicle on a highway contrary to the terms and conditions of the permit issued in respect of that Vehicle.
- 4 Section 15 is amended by adding the following after Subsection 15(1):
 - (1.1) A Person who applies for a permit under this Bylaw shall pay the applicable permit fee set out in Schedule "B" of this Bylaw.
- 5 Section 17 is amended by adding the following after Subsection 17(g):
 - (g.1) retain Persons to receive and process permit applications, issue permits and/or collect permit fees on behalf of the County;

- The Permit Fees part of Schedule "B" is amended by adding the words "per permit" after "\$25".
- 7 The Specified Penalties part of Schedule "B" is amended by adding the following after the row marked "Section 9(2)":

Section 9.1(1)	Operate Non- Standard Configuration Vehicle without a permit	\$200	\$250
Section 9.1(2)	Operate contrary to permit (Non-Standard Configuration Vehicle)	\$200	\$250

8 This Bylaw takes effect upon being passed.
