
Community Enhancement Funding

Each fall the County of Vermilion River invites community organizations to apply for funding to assist with operational funds for halls, facilities and community events. At the November 14th and December 12th Regular Meetings of Council \$385,200 was distributed to 43 community organizations for operational funding. Thank you to the organizations and their volunteers to keep halls and facilities going in our communities. Capital funding was distributed to Kitscoty Agricultural Society for the amount of \$75,000.00 to assist with their upgrades project, as well. County of Vermilion Clubroot Update 2023

- Three new clubroot positive fields were identified and confirmed, found in Division 6 and Division 7
- A total of 24 positive sites in the County
- The landowners and renters of these properties have agreed to a one in three year crop rotation and the use of clubroot resistant varieties on these sites
- County Pest Inspectors annually survey about 10% of canola fields in a random survey
- Six fields which had tested positive for clubroot in 2020 were able to come back into rotation with canola in the 2022 crop year and, no symptoms of clubroot were found during inspection.
- 12 positive fields in the County had no clubroot found after two years out of canola and 2 fields had no clubroot found after two 1-in-3 year rotations.

Best Management Practices to protect from yield loss to diseases:

- Crop rotation (at least 2 years between Brassica crops)
- Use clubroot resistant, blackleg resistant canola varieties
- Control volunteer canola and cruciferous weeds between canola crops
- Clean equipment to reduce movement of soil and spores from field to field

The County of Vermilion River and ALUS Vermilion River will work with ratepayers to help establish these “welcome mats” at field approaches, water runoff channels and low lying/wet areas and proactively manage clubroot. The County Agriculture Department can provide participating landowners with up to \$100 of perennial grass/legume seed (enough to seed about 3 acres), and access to small equipment to help with establishment. Participants may also be eligible for assistance with establishment costs from ALUS Vermilion River, and larger projects may even qualify for land payments for ecosystem services provided. ALUS Vermilion River had a successful 2023, enrolling 7 new projects for a total of 381 acres. We were very happy to welcome 6 new participants to the program, growing our total to 55 producers across the County. Two significant milestones we surpassed this year were 4500 acres and \$1,000,000 invested on-the-ground to date. These impressive numbers mean that ALUS is not only improving the agricultural operations of local farmers and ranchers, but we are also supporting a much healthier environment for all our residents by providing cleaner water, cleaner air, carbon sequestration, erosion control, pollinator and wildlife habitat.
