A BYLAW of the County of Vermilion River in the Province of Alberta to amend Scale Of fees For Water and Sewer Utilities (Bylaw 21-22) Schedule A

NOW THEREFORE The Council of the County of Vermilion River in the Province of Alberta, duly assembled, enacts as follows:

1. That Bylaw No. 21-22, being the Scale Of fees For Water and Sewer Utilities Bylaw of the County of Vermilion River, is hereby amended as follows:
 - a. Schedule A

SHOULD any provision of this Bylaw be determined to be invalid, then such provisions shall be severed, and the remaining bylaw shall be maintained.

THIS Bylaw shall come into force and effect February 1, 2025 and having been signed by the Reeve and Chief Administrative Officer.


