

### **COUNCIL HIGHLIGHTS**

### **REGULAR MEETING OF COUNCIL – AUGUST 11, 2025**

A Regular Meeting of Council was held on August 11, 2025 at the Village of Kitscoty Council Chambers in Kitscoty. Council approved the following resolutions:

#### **PUBLIC HEARING BYLAW 25-17 CANOLA FARMS AREA**

Council held a public hearing in regard to Bylaw 25-17 Canola Farms Area Structure plan. One member of the public attended but did not speak at the hearing.

#### MARWAYNE AGRICULTURE SOCIETY CHEQUE PRESENTATION

Council presented a cheque for \$740,000.00 to the Marwayne Agriculture Society representatives Todd Hames and Yolanda Oberhofer for the Marwayne Agriplex upgrades.

# BYLAW 25-15 BEING A BYLAW TO AMEND THE COUNTY OF VERMILION RIVER MUNICIPAL DEVELOPMENT PLAN (BYLAW 19-03)

Council gave Second and Third and Final Readings to Bylaw 25-15, being a bylaw to amend the County of Vermilion River Municipal Development Plan (Bylaw 19-03), for the purpose of amending Section 5.2 Adequate Subdivision of Land to read "The combined total maximum area of land that may be subdivided from a quarter section for vacant Country Residential lots or parcels, abandoned farmstead operations, and developed Country Residential Parcels shall be 10.1 ha (25.0 ac). Subdivisions for Commercial, Industrial, Institutional and Public Uses shall be allowed in the Agricultural Area in accordance with the provisions in the County of Vermilion River Land Use Bylaw. (See Figure 3)" as amended.

#### **TAX PAYMENT**

Council approved entering into a Tax Arrears Repayment Agreement with the owner of Lot 1 Block 1 Plan 1124130 commencing August 15, 2025.

#### **DOG CONTROL - BORDER PAWS NEGOTIATIONS**

Council approved the negotiated terms with Border Paws for a three-year term to begin January 2026, with a prorated year for 2025 and a term expiry of December 31, 2028, for basic animal control services for \$50,000.00 annually.

#### **RAIL SAFETY WEEK PROCLAMATION**

Council approved the support of Rail Safety Week from September 15 to 21, 2025.

#### CLANDONALD AGRICULTURAL SOCIETY CAPITAL PROJECT

Council approved funding in the amount of \$25,0000.00 as per Policy PD 021 – Community Enhancement Funding Policy, from the Community Services Reserve to the Clandonald Agricultural Society to support the addition of dressing rooms to the Clandonald Arena.
