

## **COUNCIL HIGHLIGHTS**

### **REGULAR MEETING OF COUNCIL – SEPTEMBER 9, 2025**

A Regular Meeting of Council was held on September 9, 2025 at the Village of Kitscoty Council Chambers in Kitscoty. Council approved the following resolutions:

#### **APPOINTMENT**

Council met with Blair and Pamela Henry regarding a land access easement and restrictive covenant.

#### **TAX FORFEITURE PROPERTY**

Council approved, pursuant to Section 424(1) of the Municipal Government Act, acquiring title and becoming owner of the following property: Lot 9 Block 14 Plan 8621214 Certificate of Title 092356665.

#### ATCO ELECTRIC LTD FRANCHISE AGREEMENT - DEWBERRY

Council approved a Francise Fee of zero per cent for the Hamlet of Dewberry for 2026, down from eight percent.

#### **COUNCIL ROAD TOUR**

Council approved delaying the annual Council Road Tour until after the Municipal Election on October 20, 2025.

#### **EAST CENTRAL 911 AFRRCS**

Council approved the allocation of \$5 per capita/8,109 residents, for a cost of \$40,545.00 which is funded under the Protective Services budget.

#### LETTER TO MLA GARTH ROWSWELL REGARDING KITSCOTY INTERSECTION

Council approved the letter to MLA Garth Rowswell advocating for a highway overpass at the intersection of Highway 16 and Highway 897.

#### BATTLE RIVER WATERSHED ALLIANCE PER CAPITA REQUISITION

Council approved the Battle River Watershed Alliance 2025 per capita invoice of \$1,574.82 as requested.

#### LEA PARK RODEO – LETTER OF SUPPORT FOR NOMINATION RODEO OF THE YEAR

Council approved letter of support for the Lea Park Rodeo nomination for Rodeo of the Year.

#### **BYLAWS**

Council approved the following Bylaws:

Bylaw 25-14 Procedural for the purpose to repeal and replace Bylaw 23-01 Procedural. This Bylaw is for the purpose to establish the orderly proceedings of meeting led by Council and the various boards, committees, commissions and other bodies established by Council.

Bylaw 25-18 Public Safety that expands on the provisions related to stray canine control and repeals and replaces Bylaw 23-16 Public Safety.
