

COUNCIL HIGHLIGHTS

REGULAR MEETING OF COUNCIL - SEPTEMBER 23, 2025

A Regular Meeting of Council was held on September 23, 2025 at the Village of Kitscoty Council Chambers in Kitscoty. Council approved the following resolutions:

EAST HALF OF SECTION 33-49-2 W4M ACCESS ROAD

Council approved a motion to obtain ownership of the road in the East Half of Section 33-49-2 W4M by surveying the road to become a registered road plan of 30 meters in width (as per the Policy PD 014 General Municipal Servicing Standards) and purchase the road from the landowner for one dollar (\$1.00). Due to the history of the road, the landowner does not have to upgrade this road to current County of Vermillion River standards; and furthermore, that the County of Vermillion River incur all survey and transfer costs estimated to be not more than \$8,000.00 and to be funded from Planning and Development Contracted Services budget.

RED FEATHER RIDGE - SNOW PLOW FLAG

Council approved the provision of a snow plow flag for the Ratepayer fee as defined in the current fee bylaw for Red Feather Ridge located at NE-20-49-7-W4M with the conditions that there is confirmation the facility is utilized at no charge to community groups, and all other guiding principles of PW 015 Snow Plow Flag are applicable.

PURCHASE OF USED WATER TRUCK

Council approved the purchase of a used water truck from Summit Truck Equipment Canada for the purchase price of \$259,900.00 excluding GST with funding from the Public Works Capital Budget.

Council approved the appointment of Kendall Leuschen as the Agriculture Fieldman for 2025
